# INDUSTRY-SUPPORTED SYMPOSIA GUIDELINES



A symposium must be a strictly educational function that may or may not offer CME credit. These events are subject to the restrictions listed in these guidelines.

Only ACP-approved symposia are permitted. It is imperative that all employees of the CME Provider, Supporting Organization(s), and Program Organizer and all agents are made aware of the following guidelines, as they may affect your eligibility for involvement with future ACP Internal Medicine Meetings ([see Violations on page 11](#)).

## Application and Administrative Fee Requirements Deadline: January 21, 2026

Completed applications including all required signatures and documentation are strongly encouraged to be submitted by January 21, 2026 to secure a preferred time slot and inclusion in ACP promotional materials. (*Please note:* the symposium fee must be paid in full for promotional inclusion.)

Applications will be accepted until all 16 time slots are filled, or no later than March 1, 2026\*, whichever comes first.

ACP reserves the right to cancel any application if payment is not received by the stated deadline.

## Lunch Symposia

Two lunch symposium slots will be available on Tuesday, April 14, and two on Wednesday, April 15.

**Time Slot:** 12:15 to 1:15 p.m.

**Registration:** Noon

**Estimated Attendance\*:** 250 to 350

**Location:** Convention Center

*It is a requirement for a meal to be served during this time slot.*



## Dinner Symposia

Dinner symposium slots will be available from Wednesday, April 15, to Friday, April 17.

**Time Slot:** Program can begin after 6:30 p.m.

**Registration:** Permitted to begin 30 minutes before approved time.

**Estimated Attendance\*:** CME: 200 to 300;  
Non-CME\*: 50 to 100

**Location:** The Convention Center is not available for evening symposia; refer to page 6. However, ACP will hold function space in several hotels in our housing block for the purpose of Industry-Supported Symposia.

\* Estimated attendance is based on past in-person Internal Medicine Meetings.

## Cancellation Deadline: January 21, 2026

Cancellations must be submitted in writing and will be processed using the date of receipt as the official cancellation date. If the notice of cancellation is received:

- On or before January 21, 2026—50% cancellation fee
- On or after January 22, 2026—100% cancellation fee

No refunds will be provided for those companies that cancel their program after January 21, 2026.

**Applications submitted after January 21, 2026, will incur a 100% cancellation fee once the program is approved by ACP.**

### Adherence to External Guidelines

It is the responsibility of the Industry-Supported Symposia CME Provider/Accredited Sponsor, Commercial Supporter, and Organizer of the program to comply with the U.S. Food and Drug Administration (FDA) regulations, policies, practices, and guidelines and all other industry guidelines, including the PhRMA Code on Interactions With Health Care Professionals, concerning the discussion, demonstration, use, and/or display of products, technologies, and/or services during all symposia.

### CME Provider/Accredited Sponsor

The accredited CME Provider plans the CME content and designates the symposium for a CME credit (for example, a hospital or university). On approval to hold a CME symposium, ACP must be notified immediately if the CME Provider or Supporter(s) listed on the application changes.

### Commercial Supporter

The Commercial Supporter is the organization(s) that provides funding for the symposium program (for example, a pharmaceutical or medical supply company).

### Convention Center

The Moscone Center is available only for approved lunch symposia. Your room assignment will be included in your approval e-mail. A service manual will be provided for lunch programs to include details on shipping and materials handling charges. *Lunch symposia being held at the Convention Center will require that a meal be served.*

### Disclaimer

ACP is not responsible for unsatisfactory outcomes of Industry-Supported Symposia.





## Enduring Material

Enduring material based on Industry-Supported Symposia are permissible; however, the following restrictions apply: ACP must be notified via e-mail, before production, if derivatives will be made. The notification must include the following information:

- Format, such as on-demand or web-based platforms
- Who will receive the derivative and how it will be distributed
- Whether the audience will be captured (video or audio recording)

“No Implied Endorsement” as outlined below applies to enduring materials and all associated promotional materials.

## Faculty

Please note that, because of a conflict of interest, ACP leadership cannot present or speak at symposia. Faculty should be internal medicine physicians; however, an exception may be made if content is more appropriately presented by a representative of another specialty.

## Food, Beverages, and Entertainment

Please refer to the PhRMA Code on Interactions With Health Care Professionals, AdvaMed codes, and CMS Open Payments Program on food and beverage items from supporters. To maintain focus on the education and research presented, no entertainment or performance, live or otherwise, may be offered before, during, or after the event. The Organizer of the program is responsible for all food and beverages.



## Hotel Meeting Rooms

ACP will hold function space in several hotels in our housing block for the purpose of Industry-Supported Symposia. The hotels will release space on a first-come, first-served basis to companies that have been approved. *Hotels will not assign space for symposia without confirmation of ACP approval. ACP does not assign space; therefore, you must contact your preferred hotel(s) directly to make arrangements for your event.* A list of hotels and contact names will be included with your approval e-mail. Dinner symposia cannot be held in the Convention Center.

## Indemnity

The CME Provider, Commercial Supporter, and Organizer of the program (if applicable) agree to indemnify and hold ACP harmless from any claims or damages to persons or property that arise from the Industry-Supported Symposium program and to add ACP as an additional insured on its liability insurance for the program.

## Invitations and Promotions

The CME Provider or Organizer of the program must control the content of all invitational or promotional material. Any and all invitations or solicitations to attend an Industry-Supported Symposium must receive ACP approval before printing, distribution, or posting. Invitations and announcements addressed to Internal Medicine Meeting 2026 registrants should clearly indicate the name(s) of the organization(s) funding the program and the CME Provider, and must in no manner mention, directly or indirectly, ACP.

- **Any URL used for registration may not contain any reference to ACP or the Internal Medicine Meeting** (for example, [www.symposia.topic/IMM2026](http://www.symposia.topic/IMM2026) is not acceptable).
- **All promotional materials must show the following disclaimer statement on the cover/front page:** *“This event is not a part of the official Internal Medicine Meeting 2026 Education Program. CME credit is provided by organizations other than ACP.”*
- **Non-CME symposia must include the following statement:** *“This event is not part of the official Internal Medicine Meeting Education Program and does not offer CME credit.”*
- Distribution of literature, including invitations, is to be confined to the supporter’s exhibit booth in the Convention Center. Any other form of distribution (including from the hotel or Convention Center lobby) is not permitted. Under no circumstances may promotional materials be distributed to attendees at any of the participating hotels. The Commercial Supporter is subject to the Violations of Regulations, as stated in the violation information included on **page 11**.





## No Implied Endorsement

Industry-Supported Symposia are considered unofficial programs (not supported by ACP). Therefore, there can be no implication in any promotional materials or mailers, or during these events, that the symposia programs are connected with Internal Medicine Meeting 2026, presented in cooperation with ACP, or endorsed by ACP. In describing these events, you may not use such phrases as “presented during,” “presented in conjunction with,” or “prior to” Internal Medicine Meeting 2026. The use of Internal Medicine Meeting 2026 or the ACP name, logo, or seal is strictly prohibited, with the exception of the required disclaimer statement described in “Invitations and Promotions” above. Faculty for Industry-Supported Symposia should be informed of these restrictions.

## Non-CME Programs

Non-CME Symposia must be medical or educational in nature.

## Onsite Materials

ACP does not require review of onsite handout materials before the event. If pharmaceutical options or recommendations are included as part of the activity, ACP recommends that the handout materials include an index of the generic names of all drugs in that class, in alphabetical order, with their corresponding trade names listed beside them. This will be a helpful reference tool for physicians. No indication of preference for one drug over another may be made, and the list should be comprehensive.

## Onsite Registration

Registration for dinner events at the event location may open 30 minutes before the approved start time. Registration for lunches in the Convention Center may open at noon. Registration is managed by the CME Provider or the Organizer.

## Organizer of the Program

The Organizer is the group (for example, a communications company, third-party planner, or agency) that handles all details and logistics for the symposium.

## Program

Strictly educational functions that may or may not offer CME credit; these events are subject to the restrictions listed in these guidelines, and only ACP-approved symposia are permitted





## Signage

- A maximum of three 28" x 44" and one 1-meter signs are permitted. Double-sided or A-frame signs will be allowed. The 1-meter sign may only be placed just outside the door to your meeting room. Signs may only be placed in the hotel or venue where the function is being held, on the day of the event, with the hotel's permission. **Signs may NOT contain invitation holders.**
- Dinner program signs will be posted on the day the program will be held.
- Individual program signs or invitations may not be placed inside or around the Convention Center or at hotels where the event is not taking place. Signs/invitations may be placed within the CME Provider or Commercial Supporter's exhibit booth. ACP will strategically place signs (that ACP will create) in the Convention Center to promote all symposia programs. Other signs, including handheld signs, sandwich boards, and pop-up signs/banners (over 1-meter), are prohibited. Invitations may not be handed out in the lobby of the hotel or venue at any time.

- **ACP will remove signs over the limit of four or those listed as prohibited above, without notice.**
- **Lunch Symposia:** A maximum of three 28" x 44" and one 1-meter signs are permitted in the Convention Center. One of these signs is permitted to be displayed at the Headquarter Hotel on the day of the event.
- **All signage and promotional materials must show the following disclaimer statement:** "This event is not part of the official Internal Medicine Meeting 2026 Education Program. CME credit is provided by organizations other than ACP."
- **Non-CME symposia must include the following statement:** "This event is not part of the official Internal Medicine Meeting Education Program and does not offer CME credit."
- ACP is not responsible for lost or damaged signage.

## Standards for Integrity and Independence in Accredited Continuing Education Guidelines

Please note that ACP does not provide CME credit for Industry-Supported Symposia. In addition, ACP reminds sponsors of educational events that adherence to the Standards for Integrity and Independence in Accredited Continuing Education is required. Commercial Supporters will observe all ACP and, if applicable, Standards for Integrity and Independence in Accredited Continuing Education and American Medical Association (AMA) guidelines.

## Transportation

If transportation is provided, please use clearly marked signage on vehicles to avoid confusion. ACP shall assume no responsibility for transportation.





## Violations

To protect the integrity and quality of the Symposia Program and to ensure a successful outcome for all parties involved, ACP requires each Organizer and CME Provider to agree that it and its employees, speaker(s), Program Organizers, and Commercial Supporters will observe all ACP and, if applicable, Standards for Integrity and Independence in Accredited Continuing Education and AMA guidelines. ACP, at its sole discretion, reserves the right to revoke privileges for future ACP annual meetings for any Commercial Supporter, CME Provider, or Organizer of the symposium program involved in planning an unofficial CME symposium that does not comply with the aforementioned guidelines. Violations of ACP Industry-Supported Symposia guidelines, Standards for Integrity and Independence in Accredited Continuing Education, or the AMA's Ethical Opinion on Gifts to Physicians From Industry will result in a 1-year probation. During the probationary period, ACP will accept no applications for review of any programs from the sponsoring organization. If a symposium is found to have violated ACP rules and regulations, the Commercial Supporter, CME Provider, or Organizer of the program will be prohibited from participating in an Industry-Supported Symposium the following year. ACP reserves the right to cancel Industry-Supported Symposia and retain any administrative fees in the event of violations of ACP Industry-Supported Symposia guidelines, Standards for Integrity and Independence in Accredited Continuing Education, or the AMA's Ethical Opinion on Gifts to Physicians From Industry that occur before the scheduled program.

## Virtual Programs

Livestream and on-demand opportunities are available, allowing additional exposure to all attendees for up to 30 days and 1 year for attendees who purchased premium access. Only Symposia offering CME credit will be eligible. The Organizer of the program is responsible for all coordination, cost, and production of livestream and/or on-demand recording. The weblink to access program content on the Organizer's hosted platform must be provided to ACP in advance. Instruction must be included to attendees on how to claim their CME. All content must be compliant with the No Implied Endorsement guidelines on page 9. All presentations must show the following disclaimer statement on the first slide: "This event is not a part of the official Internal Medicine Meeting 2026 Education Program. CME credit is provided by organizations other than ACP." Virtual attendance is not guaranteed. Livestream will only be accessible at the time of your approved time slot.
